2021 Parent Conduct Agreement

- \* Encourage your daughter to play by the rules. Be a positive role model of sportsmanship for your daughter. Show a positive attitude toward the game and all of the participants. Applaud the good play of both teams. Applaud a good effort in victory and in defeat, reinforce the positive points of the game.
- \* Be respectful to the officiating crews throughout tournaments. Yelling at anyone that is officiating a match will not be tolerated.
- \* Playing time is the decision of the head coach. Respect their experience and judgment. Communicate with them and support them. **Do not approach a coach regarding playing time during a tournament or practice.** If you wish to discuss this issue please make an appointment with the coach at a mutually convenient time.
- \* Emphasize the importance of skill development and participation at practice. Please understand that if a player does not participate in practices the coach may limit playing time at the following tournament.
- \* Most pertinent information regarding the club will be distributed through email or sent home with your daughter from practice and will be posted on our website [www.billingsavalanche.com](http://www.billingsavalanche.com). If you ever have questions about upcoming events feel free to contact your coach or the club director.
- \* Each player is required to be a current member of AAU and will not be able to participate in any practices or tournaments until this registration is completed and verified by the club director.
- \* Club payment and fees are to be received as explained in the 2021 financial agreement. Athletes will not be allowed to participate in any club activity without these requirements being met. Please mark in the notes what the payment is for. If you have any questions concerning payments please contact the club director. Should your daughter decide not to complete the season there will be no waiver or refund.
- \* Medical waiver, financial agreement, player code of conduct, parent conduct agreement, and first payment must be turned in before your daughter will be allowed to participate in any club activity.
- \* Travel accommodations to and from tournaments are the responsibility of the players and their families. Tournaments are not guaranteed, and if some of them are cancelled, we are working to arrange scrimmages with other area clubs.
- \* Team officiating responsibilities are to be shared equally. No team member is allowed to leave the facility until the match your team is officiating is completed. An exception may be made by the coach in extenuating circumstances.
- \* The tournament and practice schedules are subject to change. We will make every effort to give you enough time to make arrangements if changes are to happen.
- \* All players and parents will be expected to assist with tournaments hosted by Billings Avalanche, LLC or pay the \$50 fee. Sign-up sheets for the tournaments will be sent to parents via email.
- \* Practices are open to parents. If you choose to attend practice, please be respectful and keep negative opinions to yourself. If you need to speak with the coach, please contact the coach to set up a time to meet.
- \* The club director is available to meet with you by phone or appointment. We want to provide all players with a positive athletic experience and will do everything in our power to do so.
